- 3. Don't equate your experience with theirs. Accept that the person's experience is unique.




- 4. After you have said something once, do not repeat yourself because it is condescending.



Winter Solstice – December 21, 2016 at 5:44 am

There are still 24 hours in the "shortest day of the year," there is just less sunlight. Because of the tilt of the earth, the northern hemisphere gets less sun each day during the winter. The first day of winter marks the day with the least amount of sunlight and the sun is at its most southerly point. On December 22nd this year, the days will start 'getting longer.'

Many of our winter traditions are based on the winter solstice:

- During ancient times the Yule log was lit to ward off evil spirits on the winter solstice.
- People believed that the sun stood still for 12 days during this time (maybe the 12 days of Christmas).
- It is widely believed that this time of year was chosen as the time to celebrate the birth of the Christian Savior, because it was the time of a pagan celebration of the rebirth of the sun.

Winter solstice can happen any time between December 20 and 23. December 21 or 22 solstices happen most often. The last December 23 solstice was in 1903 and will not happen again until 2303. A December 20 solstice has occurred very rarely, with the next one in the year 2080.
