Irish Soda Bread Cookies



Ingredients

3

1

-	
2 cups all purpose flour	1/4 cup buttermilk
3/4 cups white sugar	1/2 cup butter
1/2 teaspoon baking soda	1/4 teaspoon salt
1 teaspoon caraway seed	1 egg
1/2 cup dried currants	

Preheat oven to 350 degrees

Directions

Combine all dry ingredients into mixing bowl. Cut in butter with a pastry blender until mixture resembles coarse meal. Blend in currents.

Beat egg until. Mix into dry ingredients.

Pour in milk and mix with a fork to make a soft dough

(you may need to add more milk).

Shape dough into a ball and knead lightly on a floured surface.

Roll dough to 1/4 inch thick and cut into approximately

2 inch squares, triangles or circles.

Bake for 12 to 14 minutes or until lightly browned.
